Puppy Jake Foundation (PJF) has the following expectations during the adoptee:

- Adoptee will assume all financial responsibility for the dog.
- The dog will live inside with individual/family and not housed outside, not tied outside to a tether or chain.
- The dog will be seen by the adoptee's veterinarian within 30 days of adoption and provide documentation of the visit to PJF.

- Adoptee will continue proper veterinary care; remain current on all immunizations; heart worm preventative; flea control and periodic stool checks.
- Puppy Jake Foundation retains the right of first refusal in ANY instance where the adoptee is unable or unwilling to care for the service dog.
  - If for any reason adoptee cannot or does not want to keep this dog, Puppy Jake Foundation must be informed and has right of first refusal to the dog. From the time Puppy Jake Foundation receives notice of such, Puppy Jake Foundation will have 30 days to exercise its right of first refusal to have the dog returned to Puppy Jake Foundation.
