It is with great pleasure that I share with you that in 2019, Puppy Jake Foundation achieved accreditation from Assistance Dogs International (ADI). ADI is an international organization that sets standards in all aspects of an assistance dog organization. PJF began the process in 2014 – and yes, it took five years to obtain accreditation. When Puppy Jake completed the rigorous process and met the high standards set by ADI, there were only 89 organizations in the United States to have achieved accreditation. Having received accreditation, the Veterans we serve will now have additional benefits at the VA. Hats off to the entire PJF team for reaching this tremendous level of excellence.

February 2020 marks eight years of Puppy Jake Foundation working to help the lives of wounded Veterans with a service dog. Looking back over last year, I continue to be amazed at the growth and expansion of Puppy Jake Foundation. Seven more Veterans received their service dogs in 2019, bringing the number to 27 working Veteran/service dog teams. Another Team Training (graduating class) is scheduled for summer of 2020. As we continue to strive to aid our nation's Heroes, I am pleased to share that the teams are working well together.







The PJF training team evolved in many ways in 2019. Erin Topp was promoted to Training Director joining Assistant Trainers Kelly Bass, Marianne Cary and Janice Rosenburg.

Erin started her dog-training journey at age ten in a local 4-H dog project. Erin has participated with her five personal dogs in competition obedience, agility, K9 Nose work®, and lure coursing. Erin serves as Communication Director for the Karen Pryor Academy team. She is a Professional Certified Trainer from Karen Pryor Academy (KPA-CTP), member of the Association of Professional Dog Trainers (ADPT) and evaluator for the American Kennel Club (AKC).

Kelly recently completed Karen Pryor Academy's Dog Trainer Professional course and received her KPA-CTP certification. She has taken classes with American Kennel Club (AKC) Breeding and continues to learn as much as she can in regard to training.

Marianne has been with PJF for years – as a foster family and currently an Assistant Trainer. She spends her time working One on One with the PJF service dogs in training. Janice is a Professional Certified Trainer from Karen Pryor Academy (KPA-CTP) and helps with One on One evaluations.

Service Dog Etiquette:

What should you do when you see a Service Dog? What is proper Service Dog etiquette?

Smile and be polite to the Service Dog's handler, but most of all:

- Do not pet the Service Dog.
- Do not distract the Service Dog in any way.
- Please ignore the Service Dog entirely.
 You are not being rude if you don't acknowledge its presence.

Some disabled Service Dog handlers don't like to chat about their Service Dogs. Most like to go about their day, just like you! Also, never ask personal questions about the handler's disability or intrude on their privacy. Keep these simple tips in mind when you see a Service Dog in public!
