As we enter 2018, Puppy Jake Foundation will have been in existence for just five short years. Looking back over the year 2017, I continue to be amazed at the growth and expansion of Puppy Jake Foundation. Nine Veterans received their service dogs in 2017, bringing the total number of working graduate teams to eighteen. As we continue to strive to aid our nation's Heroes, I am pleased to share that the teams are working well together.

Financial support from individuals and the community exceeded expectations. Having said that, the task of raising money is never ending. Puppy Jake Foundation insists that full funding, and a volunteer foster family is in place, prior to obtaining a new puppy. As PJF begins 2018, there are thirty-five service dogs in various stages of training; projected arrival of sixteen puppies; and two graduating classes of veterans and service dogs. In the most basic sense, fulfilling Puppy Jake Foundation's mission of providing professionally trained service dogs to wounded military veterans would not occur without your support.

Puppy Jake Foundation will continue to increase our funding and profile in the coming year so we may help those brave men and women who have given so selflessly to protect our freedom.


A Night to Honor America's Heroes
